

## **Resource Capital Corp. Declares Quarterly Cash Dividend**

(NYSE: RSO) ("RCC") announced today that its Board of Directors has declared a cash dividend of \$0.25 per common share for the quarter ending March 31, 2010. The dividend will be paid on April 27, 2010 to holders of record on March 31, 2010.

RCC's investment strategy focuses on commercial real estate-related assets and, to a lesser extent, higher-yielding commercial finance assets. RCC invests in the following asset classes: commercial real estate-related assets such as whole loans, A-notes, B-notes, mezzanine loans and mortgage-related securities and commercial finance assets such as other asset-backed securities, senior secured corporate loans, equipment leases and notes, trust preferred securities, and debt tranches of collateralized debt obligations.

RCC is externally managed by Resource Capital Manager, Inc., an indirect wholly owned subsidiary of Resource America, Inc. (NASDAQ: REXI), a specialized asset management company that uses industry specific expertise to generate and administer investment opportunities for its own account and for outside investors in the real estate, commercial finance and financial fund management sectors.
