(NYSE: RSO) (the "Company") announced today that it will pay a cash dividend on its 8.50% Series A Cumulative Redeemable Preferred Stock for the period from January 31, 2015 through and including April 30, 2015 in the amount of \$0.53125 per share. The dividend will be payable on April 30, 2015 to holders of record on April 1, 2015.

Resource Capital Corp. will also pay a cash dividend on its 8.25% Series B Cumulative Redeemable Preferred Stock for the period from January 31, 2015 through and including April 30, 2015 in the amount of \$0.515625 per share. The dividend will be payable on April 30, 2015 to holders of record on April 1, 2015.

Resource Capital Corp. will also pay a cash dividend on its 8.625% Series C Cumulative Redeemable Preferred Stock for the period from January 31, 2015 through and including April 30, 2015 in the amount of \$0.539063 per share. The dividend will be payable on April 30, 2015 to holders of record on April 1, 2015.

RSO is a real estate investment trust that is primarily focused on originating, holding and managing commercial mortgage loans and other commercial real estate-related debt and equity investments. The Company also makes other commercial finance investments. The Company is externally managed by Resource Capital Manager, Inc., an indirect wholly-owned subsidiary of Resource America, Inc. (NASDAQ: REXI), an asset management company that specializes in real estate and credit investments.
