(NYSE: RSO) (the "Company") announced today that it will pay a cash dividend on its 8.50% Series A Cumulative Redeemable Preferred Stock for the period from May 1, 2015 through and including July 30, 2015 in the amount of \$0.53125 per share. The dividend will be payable on July 30, 2015 to holders of record on July 1, 2015.

Resource Capital Corp. will also pay a cash dividend on its 8.25% Series B Cumulative Redeemable Preferred Stock for the period from May 1, 2015 through and including July 30, 2015 in the amount of \$0.515625 per share. The dividend will be payable on July 30, 2015 to holders of record on July 1, 2015.

Resource Capital Corp. will also pay a cash dividend on its 8.625% Series C Cumulative Redeemable Preferred Stock for the period from May 1, 2015 through and including July 30, 2015 in the amount of \$0.539063 per share. The dividend will be payable on July 30, 2015 to holders of record on July 1, 2015.

RSO is a real estate investment trust that is primarily focused on originating, holding and managing commercial mortgage loans and other commercial real estate-related debt and equity investments. The Company is also active in commercial finance, including through Northport Capital, its middle market lending platform. The Company is externally managed by Resource Capital Manager, Inc., an indirect wholly-owned subsidiary of Resource America, Inc. (NASDAQ: REXI), an asset management company that specializes in real estate and credit investments.
