

Resource Capital Corp. Declares Quarterly Cash Dividend

(NYSE: RSO) (the "Company") announced today that its Board of Directors has declared a cash dividend of \$0.05 per common share for the quarter ending December 31, 2016. The dividend will be paid on January 27, 2017 to holders of record on December 30, 2016.
