The Company will also pay a cash dividend on its 8.25% Series B Cumulative Redeemable Preferred Stock for the period from July 31, 2017 through and including October 30, 2017 in the amount of \$0.515625 per share. The dividend will be payable on October 30, 2017 to holders of record on October 2, 2017.

The Company will also pay a cash dividend on its 8.625% Series C Cumulative Redeemable Preferred Stock for the period from July 31, 2017 through and including October 30, 2017 in the amount of \$0.539063 per share. The dividend will be payable on October 30, 2017 to holders of record on October 2, 2017.

RSO is a real estate investment trust that is primarily focused on originating, holding and managing commercial mortgage loans and other commercial real estate-related debt investments. The Company is externally managed by Resource Capital Manager, Inc., which is an indirect wholly-owned subsidiary of C-III Capital Partners LLC, a leading commercial real estate investment management and services company engaged in a broad range of activities.
